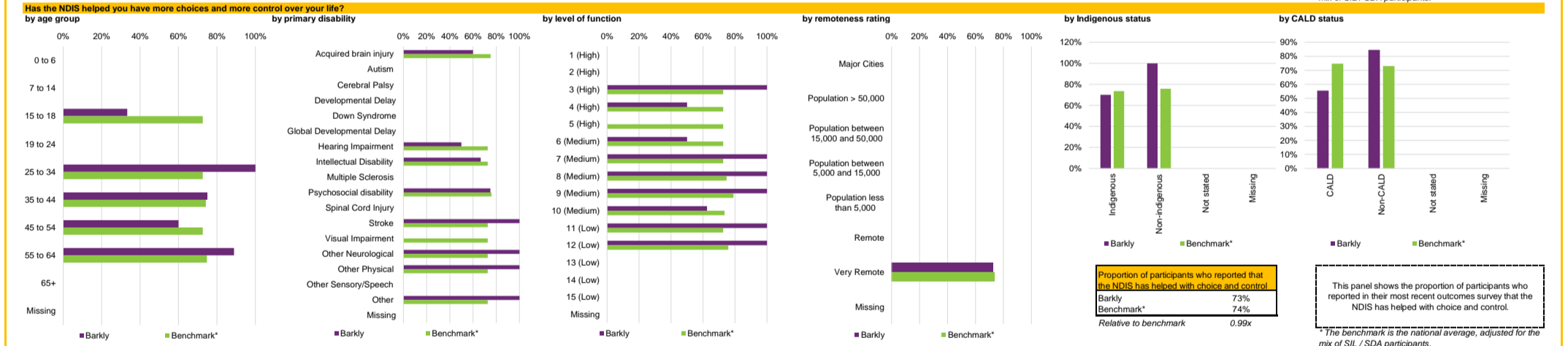
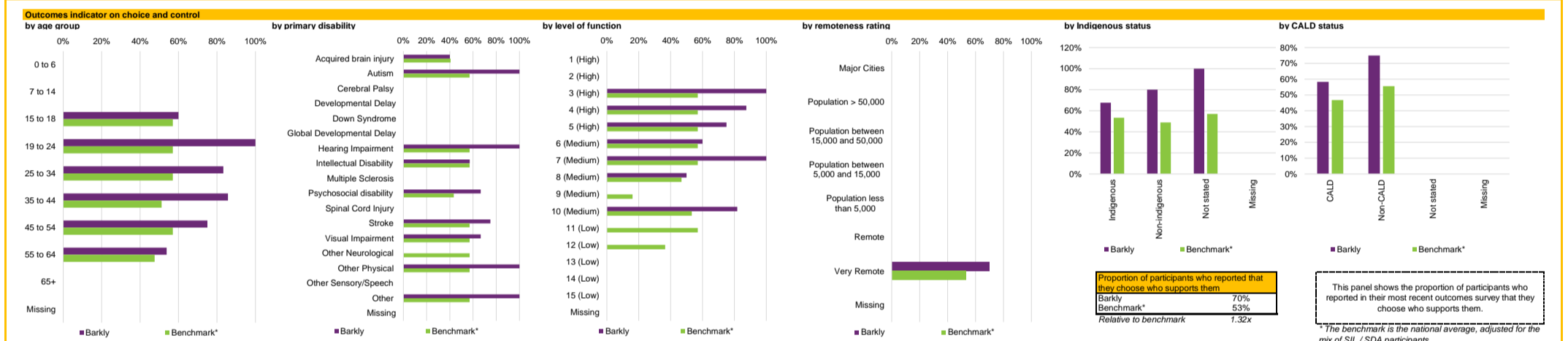


Plan utilisation

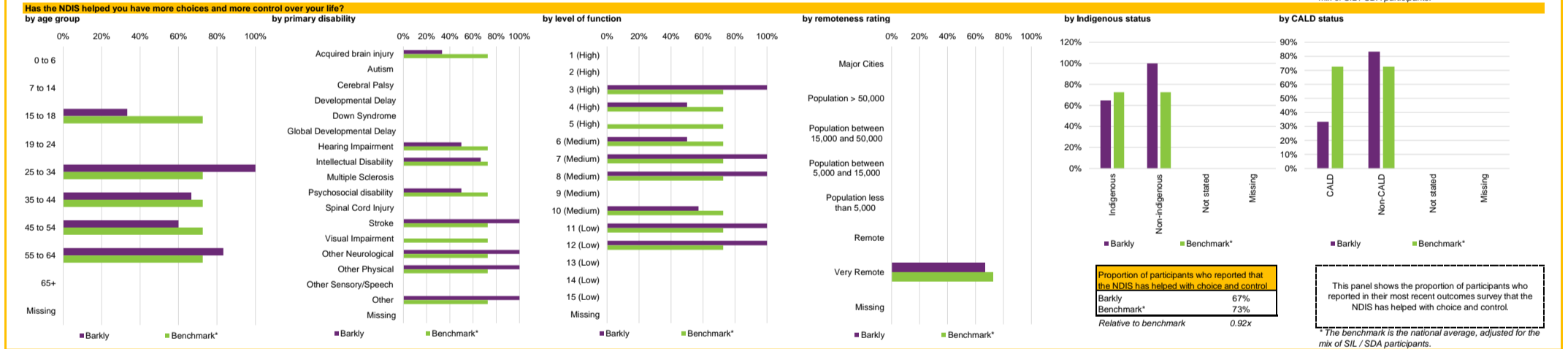
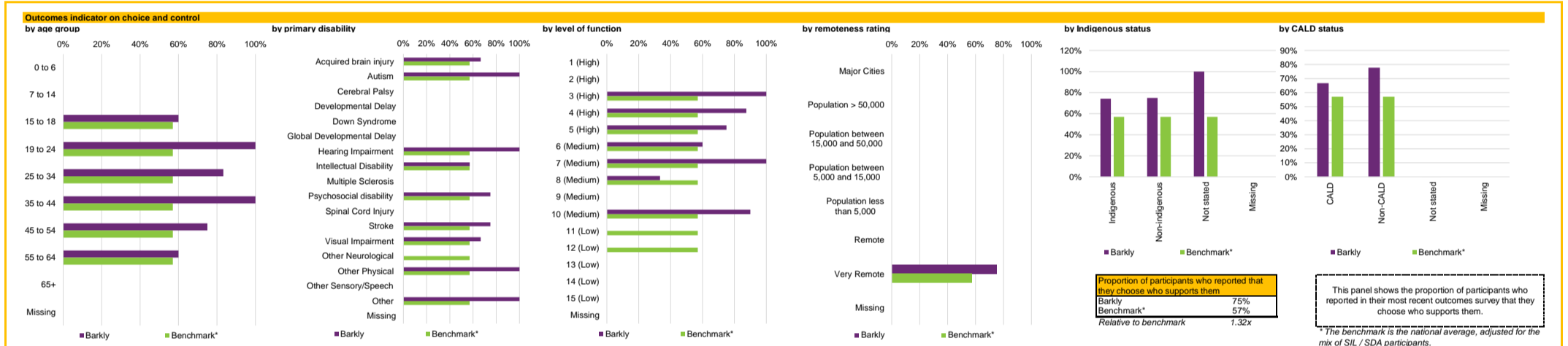


Plan utilisation
