Analysis of committed supports, payments and utilisation trends

This report builds on data relating to committed supports, and utilisation of plan budgets shared in the [30 June 2022 NDIS Quarterly Report to Disability Ministers](#) . With a data range from 30 June 2019 to 30 June 2022.

The analysis focuses on trends relating to committed supports, payments and utilisation by

- age group and number of plans
- Supported Independent Living (SIL) status
- disability status (non-SIL)
- gender, Aboriginal and Torres Strait Islander and CALD status and by State or Territory for all participants

The analysis shows year-on-year increase in average payments over the last four years by SIL status and age group (non-SIL only).

Plan budgets, average payments and utilisation analysis from 2017 to 2021

The 30 June 2021 NDIS Quarterly Report to Disability Ministers included an analysis of 12-month average payments for the years ending 30 June 2017 to 30 June 2021 by Supported Independent Living (SIL) status and age group.

The analysis indicated a consistent increase in average payments over the last four years by SIL status and age group (non-SIL only).

This report provides trends in plan budgets, payments and utilisation, across age groups and plan number.

It includes information by SIL status, by disability type (non-SIL) and by state or territory.

Plan budgets and socio-economic status report

The 30 June 2021 Quarterly Report to Disability Ministers included a chart that analysed plan budgets by socio-economic status.

The analysis indicated that on average, participants in the highest socio-economic decile received plan budgets that were 9% higher than participants in the lowest socio-economic decile

This new report takes that analysis further by looking at the distribution of plan budgets within each socio-economic decile – specifically, looking the 5th, 10th, 25th, 50th (median), 75th, 90th and 95th percentiles.
