

The Quarterly Reports provide the disability ministers with information (including statistics) about participants in each jurisdiction and the funding or provision of supports by the NDIA in each area.?

Following a recent review, some publications will move to a six-monthly cycle from Q3 2025–26. This includes supplements covering state and territory statistics (F–M), participants by service district (O), utilisation (Q), and access decisions and first plans (R).

The first six-monthly release of these publications is scheduled for Q4 2025–26.

Supplement D (State and Territory comparison), Supplement E (National) and Supplement P (Specialist Disability Accommodation) will continue to be published quarterly.
